
Minutes of the Special General Meeting

Held: On Tuesday, November 18, 2003 at 7:00 pm in the Meeting Room at 1272 Comox Street, Vancouver, BC.

Present: 18 owners in person or by proxy as per the registration sheet.

CALL TO ORDER, QUORUM REPORT: The meeting was called of order at 7:00 pm. The Property Manager noted that with 18 eligible voters, the quorum requirements set out in the bylaws had been met.

APPROVAL OF AGENDA: There were no amendments or changes to the agenda.

PROOF OF NOTICE: The Strata Manager advised that the notice was issued in compliance with the Strata Property Act.

MINUTES: It was moved, seconded and carried to adopt the minutes of the June 10, 2003, Annual General Meeting, as circulated.

RESOLUTION REQUIRING A $\frac{3}{4}$ VOTE

Be it resolved, by a resolution passed by a $\frac{3}{4}$ vote of The Owners, Strata Plan **LMS 280** approve an expenditure not to exceed **\$4,000** for purpose of upgrading the building security and including the garage door. The sum of **\$4,000** is to be charged against the owners as a special levy in proportion to the unit entitlement of their respective strata lot.

The special levy shall be assessed on **Tuesday, November 18, 2003** and any owner who sells, or transfers his/her title, including a re-mortgage, shall pay the full amount outstanding. The special levy is due and payable on or before **December 1, 2003**.

With 18 in favour, 0 opposed, the resolution was declared **passed** as it received more than $\frac{3}{4}$ of the vote's cast, in favour.

YOUR LEVY RATES ARE ATTACHED TO THE MINUTES. THE PAYMENT IS DUE AND PAYABLE ON DECEMBER 1, 2003. THE LEVY PAYMENT WILL NOT BE ADDED TO YOUR PAC ACCOUNT.
